AN ORDINANCE REQUIRING ALL PERSONS, PARTNERSHIPS, BUSINESSES, AND CORPORATIONS TO OBTAIN A BUILDING PERMIT FOR ANY CONSTRUCTION OR DEVELOPMENT; PROVIDING FOR THE ISSUANCE OF SUCH BUILDING PERMITS; SETTING FORTH CERTAIN MINIMUM REQUIREMENTS FOR NEW CONSTRUCTION AND DEVELOPMENT WITHIN AREAS OF THE TOWNSHIP WHICH ARE SUBJECT TO FLOODING; AND ESTABLISHING PENALTIES FOR ANY PERSONS WHO FAIL, OR REFUSE TO COMPLY WITH, THE REQUIREMENTS OR PROVISIONS OF THIS ORDINANCE.

BE IT ENACTED and ORDAINED by the Fannett Township, Franklin County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

ARTICLE I GENERAL PROVISIONS

Section 1.00 Intent

The intent of this Ordinance is to:

- A. Promote the general health, welfare, and safety of the community.
- B. Encourage the utilization of appropriate construction practices in order to prevent or minimize flood damage in the future.
- C. Minimize danger to public health by protecting water supply and natural drainage.
- D. Reduce financial burdens imposed on the community, its governmental units, and its residents, by preventing excessive development in areas subject to flooding.

Section 1.01 Applicability

- A. It shall be unlawful for any person, partnership, business or corporation to undertake, or cause to be undertaken, any construction or development anywhere within the Township unless a Building Permit has been obtained from the Building Permit Officer.
- B. A Building Permit shall not be required for minor repairs to existing buildings or structures.

Section 1.02 Abrogation and Greater Restrictions

This Ordinance supersedes any other conflicting provisions which may be in effect in identified floodplain areas. However, any other ordinance provisions shall remain in

full force and effect to the extent that those provisions are more restrictive.

Section 1.03 Severability

If any section, subsection, paragraph, sentence, clause, or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall remain in full force and effect, and for this purpose the provisions of this Ordinance are hereby declared to be severable.

Section 1.04 Warning and Disclaimer of Liability

The degree of flood protection sought by the provisions of this Ordinance is considered reasonable for regulatory purposes and is based on acceptable engineering methods of study. Larger floods may occur. Flood heights may be increased by man-made or natural causes, such as ice jams and bridge openings restricted by debris. This Ordinance does not imply that areas outside any identified floodplain area, or that land uses permitted within such areas will be free from flooding or flood damages.

This Ordinance shall not create liability on the part of the Township or any officer or employee thereof for any flood damages that result from reliance on this Ordinance or any administrative decision lawfully made thereunder.

ARTICLE II ADMINISTRATION

Section 2.00 Building Permits Required

Building Permits shall be required before any construction or development is undertaken within any area of the Township.

Section 2.01 Issuance of Building Permit

- A. The Building Permit Officer shall issue a Building Permit only after it has been determined that the proposed work to be undertaken will be in conformance with the requirements of this and all other applicable codes and ordinance.
- B. Prior to the issuance of any building permit, the Building Permit Officer shall review the application for permit to determine if all other necessary government permits required by State and Federal laws have been obtained, such as those required by the Pennsylvania Sewage Facilities Act (Act 1966-

•

537, as amended); the Pennsylvania Dam Safety and Encroachments Act (Act 1978-325, as amended); the Pennsylvania Clean Streams Act (Act 1937-394, as amended); the U.S. Clean Water Act, Section 404, 53, U.S.C. 1334. No permit shall be issued until this determination has been made.

C. No encroachment, alteration, or improvement of any kind shall be made to any watercourse until all adjacent municipalities, which may be affected by such action, have been notified by the Township and until all required permits or approvals have been first obtained from the Department of Environmental Resources, Bureau of Dams and Waterway Management.

In addition, the Federal Insurance Administrator and Pennsylvania Department of Community Affairs, Bureau of Community Planning, shall be notified by the Township prior to any alteration or relocation of any watercourse.

Section 2.02 Application Procedures and Requirements

- A. Application for such a building permit shall be made, in writing, to the Building Permit Officer on forms supplied by the Township. Such application shall contain the following:
 - 1. Name and address of applicant.
 - 2. Name and address of owner of land on which proposed construction is to occur.
 - 3. Name and address of contractor.
 - 4. Site location.
 - 5. Listing of other permits required.
 - 6. Brief description of proposed work and estimated cost.
 - 7. A plan of the site showing the exact size and location of the proposed construction as well as any existing buildings or structures.
- B. If any proposed construction or development is located entirely or partially within any identified floodplain area, applicants for Building Permits shall provide all necessary information in sufficient detail and clarity to enable the Building Permit Officer to determine that:

- (a) all such proposals are consistent with the need to minimize flood damage and conform with the requirements of this and all other applicable codes and ordinances:
- (b) all utilities and facilities, such as sewer, gas, electrical and water systems are located and constructed to minimize or eliminate flood damage; and
- (c) adequate drainage is provided so as to reduce exposure to flood hazards.

Applicants shall file the following minimum information plus any other pertinent information (e.g., any or all of the technical information contained in Subsection 2.02C.) as may be required by the Building Permit Officer to make the above determination:

- 1. A completed Building Permit Application Form.
- 2. A plan of the entire site, clearly and legibly drawn at a scale of one (1) inch being equal to one hundred (100) feet or less, showing the following:
 - a. north arrow, scale, and date;
 - b. topography based upon the National Geodetic Vertical Datum of 1929, showing existing and proposed contours at intervals of two (2) feet;
 - c. all property and lot lines including dimensions, and the size of the site expressed in acres or square feet;
 - d. the location of all existing streets, drives, other accessways, and parking areas, with information concerning widths, pavement types and construction, and elevations;
 - e. the location of any existing bodies of water or watercourses, buildings, structures and other public or private facilities, including railroad tracks and facilities, and any other natural and man-made features affecting, or affected by, the proposed activity or development;
 - f. the location of the floodplain boundary line, information and spot elevations concerning the one hundred (100) year flood elevations, and information concerning the flow of water including direction and velocities;

.

- g. the location of all proposed buildings, structures, utilities, and any other improvements; and
- h. any other information which the municipality considers necessary for adequate review of the application.
- 3. Plans of all proposed buildings, structures and other improvements, clearly and legibly drawn at suitable scale showing the following:
 - a. sufficiently detailed architectural or engineering drawings including floor plans, sections, and exterior building elevations, as appropriate;
 - for any proposed building, the elevation of the lowest floor (including basement) and, as required, the elevation of any other floor;
 - c. complete information concerning flood depths, pressures, velocities, impact and uplift forces, and other factors associated with the one hundred (100) year flood;
 - d. detailed information concerning any proposed floodproofing measures.
 - e. cross-section drawings for all proposed streets, drives, other accessways, and parking areas, showing all rights-of-way and pavement widths;
 - f. profile drawings for all proposed streets, drives, and vehicular accessways including existing and proposed grades; and
 - g. plans and profiles of all proposed sanitary and storm sewer systems, water supply systems, and any other utilities and facilities.
- 4. The following data and documentation:
 - a. certification from the applicant that the site upon which the activity or development is proposed is an existing separate and single parcel, owned by the applicant or the client he represents;
 - b. certification from a registered professional engineer, architect, or landscape architect

that the proposed construction has been adequately designed to protect against damage from the one hundred (100) year flood;

- fessional engineer, architect, landscape architect, or other qualified person which contains a complete and accurate description of the nature and extent of pollution that might possibly occur from the development during the course of a one hundred (100) year flood, including a statement concerning the effects such pollution may have on human life;
- d. a statement certified by a registered professional engineer, architect, or landscape architect, which contains a complete and accurate description of the effects the proposed development will have on one hundred (100) year flood elevations and flows;
- e. a statement, certified by a registered professional engineer, architect, or landscape
 architect, which contains a complete and
 accurate description of the kinds and amounts
 of any loose buoyant materials or debris that
 may possibly exist or be located on the site
 below the one hundred (100) year flood elevation
 and the effects such materials and debris may
 have on one hundred (100) year flood elevations
 flows;
- f. the appropriate component of the Department of Environmental Resources' "Planning Module for Land Development";
- g. where any excavation or grading is proposed, a plan meeting the requirements of the Department of Environmental Resources to implement and maintain erosion and sedimentation control;
- h. any other applicable permits such as, but not limited to, a permit for any activity regulated by the Department of Environmental Resources under Seciton 302 of Act 1978-166; and
- i. an evacuation plan which fully explains the manner in which the site will be safely evacuated before or during the course of a one hundred (100) year flood.

Section 2.03 Changes

After the issuance of a building permit by the Building Permit Officer, no changes of any kind shall be made to the application, permit, or any of the plans, specifications or other documents submitted with the application without the written consent of approval of the Building Permit Officer. Requests for any such change shall be in writing, and shall be submitted by the applicant to Building Permit Officer for consideration.

Section 2.04 Placards

In addition to the building permit, the Building Permit Officer shall issue a placard which shall be displayed on the premises during the time construction is in progress. This placard shall show the number of the building permit, the date of its issuance and be signed by the Building Permit Officer.

Section 2.05 Start of Construction

Work on the proposed construction and/or development shall begin within six (6) months and shall be completed within twelve (12) months after the date of issuance of the building or the permit shall expire unless a time extension is granted, in writing, by the Building Permit Officer. Construction and/or development shall be considered to have started with the preparation of land, land clearing, grading, filling, excavation for basement, footings, piers, or foundations, erection of temporary forms, the installation of piling under proposed subsurface footings, or the installation of sewer, gas and water pipes, or electrical or other service lines from the street.

Time extensions shall be granted only if a written request is submitted by the applicant, which sets forth sufficient and reasonable cause for the Building Permit Officer to approve such a request.

Section 2.06 Inspection and Revocation

- A. During the construction period, the Building Permit Officer or other authorized official shall inspect the premises to determine that the work is progressing in compliance with the information provided on the permit application and with all applicable Township laws and ordinances. He shall make as many inspections during and upon completion of the work as are necessary.
- B. In the discharge of his duties, the Building Permit Officer shall have the authority to enter any building,

structure, premises or developemnt in the identified flood-prone area, upon presentation of proper credentials, at any reasonable hour to enforce the provisions of this Ordinance.

- C. In the event the Building Permit Officer discovers that work does not comply with the permit application or any applicable laws and ordinances, or that there has been a false statement or misrepresentation by any applicant, the Building Permit Officer shall revoke the building permit and report such fact to the Board for whatever action it considers necessary.
- D. A record of all such inspections and violations of this Ordinance shall be maintained.

Section 2.07 Enforcement

A. Notices

Whenever the Building Permit Officer or other authorized municipal representative determines that there are reasonable grounds to believe that there has been a violation of any provisions of this Ordinance, or of any regulation adopted pursuant thereto, the Building Permit Officer shall give notice of such alleged violation as hereinafter provided. Such notice shall (a) be in writing; (b) include a statement of the reasons for its writing; (c) allow a reasonable time not to exceed a period of thirty (30) days for the performance of any act it requires; (d) be served upon the property owner or his agent as the case may require; provided, however, that such notice or order shall be deemed to have been properly served upon such owner or agent when a copy thereof has been served with such notice by any other method authorized or required by the laws of this State; (e) contain an outline of remedial action which, if taken, will effect compliance with the provisions of this Ordinance.

B. Penalties

Any person who fails to comply with any or all of the requirements or provisions of this Ordinance or who fails or refuses to comply with any notice, order of direction of the Building Permit Officer, or any other authorized employee of the municipality, shall be guilty of an offense and, upon conviction, shall pay a fine to to the Township of not less than Twenty-five (\$25.00) nor more than Three Hundred Bollars (\$300.00) plus costs of prosecution. In default of such payment, such person shall be imprisoned in county prison for a period

not to exceed ten (10) days. Each day during which any violation of this Ordinance continues shall constitute a separate offense. In addition to the above penalties, all other actions are hereby reserved including an action in equity for the proper enforcement of this Ordinance. The imposition of a fine or penalty for any violation of, or noncompliance with, this Ordinance shall not excuse the violation or noncompliance or permit it to continue and all such persons shall be required to correct or remedy such violations and noncompliances within a reasonable time. Any development initiated or any structure or building constructed, processive ted, enlarged, altered, or relocated, in noncompliance with this Ordinance may be declared by the Beard to be a public nuisance and abatable as such.

Section 2.08 Appeals

- A. Any person aggrieved by an action or decision of the Building Permit Officer concerning the administration of the provisions of this Ordinance, may appeal to the Hoard Such appeal must be filed, in writing, within thirty (30) days after the decision or action of the Building Permit Officer.
- B. Upon recent of such appeal the Board shall set a time and place, within not less than ten (10) nor more than thirty (80) days, for the purpose of considering the appeal. Notice of the time and place at which the appeal will be considered shall be given to all parties.
- C. Any person aggrieved by any decision of the Board may seek relief therefrom by appeal to court, as provided by the laws of this Commonwealth including The Pennsylvania Flood Plan Management Act.

ARTICLE III IDENTIFICATION OF FLOODPLAIN AREAS

Section 3.00 Identification

The identified floodplain area shall be any area of the Township of Fannett, subject to the one hundred (100) year flood, which is identified as Zone A. (Area of Special Flood Hazard) on the Flood Insurance Rate Map (FIRM) dated October 29. 1982, or the most recent revision thereof as issued by the Federal Emergency Management Agency (FEMA) if such a map has been prepared for the Township.

Section 3.01 Determination of the One Hundred (100 Year Flood

For the purposes of this Ordinance, the one hundred (100) year flood elevation shall be used as the basis for regu-

lation. When available, information from other Federal, State, and other acceptable sources shall be used to determine the one hundred (100) year elevation, as well as a floodway area, if possible. When no other information is available, the one hundred (100) year elevation shall be determined by using a point on the boundary of the identified floodplain area which is nearest the construction site in question.

In lieu of the above, the municipality may require the applicant to determine the elevation with hydrologic and hydraulic engineering techniques. Hydrologic and hydraulic analyses shall be undertaken only by professional engineers or others of demonstrated qualifications, who shall certify that the technical methods used correctly reflect currently accepted technical concepts. Studies, analyses, computations, etc., shall be submitted in sufficient detail to allow a thorough technical review by the (fownship, Borough, etc.).

Section 3.02 Changes in Identification of Area

The identified floodplain area may be revised or modified by the Board where studies or information provided by a qualified agency or person documents the need for such revision. However, prior to any such change, approval must be obtained from the Federal Insurance Administration (FIA).

Section 3.03 Boundary Disputes

Should a dispute concerning any identified floodplain boundary arise, an initial determination shall be made by the Township Planning Commission and any party aggrieved by this decision may appeal to the Board. The burden of proof shall be on the appellant.

ARTICLE IV GENERAL TECHNICAL REQUIREMENT

Section 4.00 General

- A. In the identified floodplain area, the development and/ or use of any land shall be permitted provided that the development and/or use complies with the restrictions and requirements of this and all other applicable codes and ordinance in force in the municipality.
- B. Within any floodway area, no new construction or development shall be permitted that would cause any increase in the one hundred (100) year flood elevation.
- C. Within any identified floodplain area, no new construction or development shall be located within the area

measured (ifty (50) feet landward from the top of bank of any materiourse.

- D. Within any identified floodplain area, the elevation of the lowest floor (including basement) of any new or substantially improved residential structure shall be one and one half (1-1/2) fect or more above the one hundred (100) year flood elevation.
- E. Within any identified floodplain area, the elevation of the lovest floor (including basement) of any new or substituting improved non-residential structure shall be one and one balf (1-1/2) feet or more above the one hundred (100) year flood elevation or be floodproofed up to that height.

Any non-residential structure, or part thereof, having a lowest floor which is not elevated to at least one and one half (1-1/2) feet above the one hundred (100) year flood elevation, shall be floodproofed in a completely or essentially dry manner in accordance with the W1 or W2 space classification standards contained in the publication ertitled "Flood-Proofing Regulations" rublished by the U.S. Army Corps of Engineers (June 1972), or with some other equivalent standard. All plans and specifications for such floodproofing shall be accompanied by a statement certified by a registered professional engineer or architect which states that the proposed design and methods of construction are in conformance with the above referenced standards.

Section 4.01 Design and Construction Standards

The following minimum standards shall apply for all construction and development proposed within any identified floodplain area:

A. Fill

If fill is used, it shall:

- 1. Fatend laterally at least fifteen (15) feet beyond the building line from all points;
- 2. Consist of soil or small rock materials only Sanitary Landfills shall not be permitted.
- 3. Be compacted to provide the necessary permeability and resistance to erosion, scouring, or settling;
- 4. Be no steeper than one (1) vertical or two (2) horizontal, unless substantiated data, justifying steeper slopes are submitted to, and approved by

the Building Permit Officer; and,

5. Be used to the extent to which it does not adversely affect adjacent properties.

B. Drainage Facilities

Storm drainage facilities shall be designed to convey the flow of storm water runoff in a sale and efficient manner. The system shall insure proper drainage along streets, and provide positive drainage away from buildings. The system shall also be designed to prevent the discharge of excess runoff onto adjacent properties.

- C. Water and Sanitary Sewer Facilities and Systems
 - 1. All new or replacement water and sanitary sewer facilities and systems shall be located, designed and constructed to minimize or eliminate flood damages and the infiltration of flood waters.
 - 2. Sanitary sewer facilities and systems shall be designed to prevent the discharge of untreated sewage into flood waters.
 - 3. No part of any on-site sewage system shall be located within any identified floodplain area except in strict compliance with all State and local regulations for such systems. If any such system is permitted, it shall be located so as to avoid impairment to it, or contamination from it, during a flood.

D. Other Utilities

All other utilities such as gas lines, electrical, and telephone systems shall be located, elevated (where possible) and constructed to minimize the chance of impairment during a flood.

E. Streets

The finished elevation of all new streets shall be no more than one (1) foot below the Regulatory Flood Elevation.

F. Storage

All materials that are buoyant, flammable, explosive, or in times of flooding, could be injurious to human, animal, or plant life, and not listed in Section 4.02, Development Which May Endanger Human Life, shall be

stored at or above the Regulatory Flood Elevation and/or floodproofed to the maximum extent possible.

G. Placement of Buildings and Structures

All buildings and structures shall be designed, located, and constructed so as to offer the minimum obstruction to the flow of water and shall be designed to have a minimum affect upon the flow and height of flood water.

H. Anchoring

- 1. All buildings and structures shall be firmly rectored in accordance with accepted engineering practices to prevent flotation, collapse, or lateral revenent.
- 2. All air ducts, large pipes, storage tanks, and other similar objects or components located below the Regulatory Blood Elevation shall be securely anchored or affixed to prevent flotation.

I. Floors. Walls and Ceilings

- 1. Wood flooring used at or below the Regulatory Flood Flooring shall be installed to accommodate a lateral expansion of the flooring, perpendicular to the flooring grain without causing structural damage to the building
- 2. Plywood used at or below the Regulatory Flood Elevation shall be of a "marine" or "water-resistant" variety.
- S. Walls and ceilings at or below the Regulatory Flood Elevation shall be designed and constructed of materials that are water-resistant and will withstand innundation.
- 4. Windows, doors, and other components at or below the Regulatory Flood Elevation shall be made of metal or other water-resistant material.

J. Paints and Adhesives

- 1. Paints or other finishes used at or below the Regulatory Flood Elevation shall be of "marine" or water-resistant quality.
- Adhesives used at or below the Regulatory Flood Elevation shall be of a "marine" or water-resistant variety.

3. All wooden components (doors, trim cabinets, etc.) shall be finished with a "marine" or water-resistant paint or other finishing material.

K. Electrical Components

- 1. Electrical distribution panels shall be at least three (3) feet above the one-hundred (100) year flood elevation.
- 2. Separate electrical circuits shall serve lower levels and shall be dropped from above.

L. Equipment

 Water heaters, furnaces, air conditioning and ventilating units, or other mechanical or utility equipment or apparatus shall not be located below the Regulatory Flood Elevation.

M. Fuel Supply Systems

1. All gas and oil supply systems shall be designed to prevent the infiltration of flood waters into the system and discharges from the system into flood waters. Additional provisions shall be made for the drainage of these systems in the event that flood water infiltration occurs

Section 4.02 Development Which May Endanger Human Life

- A. In accordance with the Pennsylvania Flood Plain
 Management Act, and the regulations adopted by the
 Department of Community Affairs as required by the
 Act, any new or substantially improved structure which
 will be used for the production or storage of any of
 the following dangerous materials or substances or which
 will be used for any activity requiring the maintenance
 of a supply (more than 550 gallons or other comparable
 volume or any amount of radicactive substances) of any
 of the following dangerous materials or substances on
 the premises, shall be subject to the provisions of
 this section, in addition to all other applicable
 provisions:
 - 1. Acetone
 - 2. Ammonia
 - 3. Benzene
 - 4. Calcium carbide
 - 5. Carbon disulfide
 - 6. Celluloid

- Gblanine
- Evdrocalorio acid
- Ω, Avdrooyenio soid
- 10. Magnesium
- Mitric acid and oxfdes of nitrogen 11.
- 12. Retrolaum products (gasoline, fuel oil, etc.)
- 13. Phosphorys
- 14. Potassium
- 15. Sodium
- Sulphur and sulphur products 13.
- Festicides (including insecticides, fungicides, 17. and rodenticides)
- Radioactive substances, insofar as such 13 substances are not otherwise regulated.
- Where permitted within any identified floodplain area, any new or substantially improved structure of the kind described in Subrection A., above, shall be:
 - 1. Elsyated or designed and constructed to remain completely dry up to at least one and one-half (1-1/8) fest above the one-hundred (100) year flood and,
 - 2. Designed to prevent pollution from the structure or actavity during the course of a one-hundred (100) year flood.

Any such structure, or part thereof, that will be built below the Regulatory Flood Elevation shall be designed and constituted in accordance with the standards for completely dry flood-proofing contained in the publication "Flood-Proofing Regulations" (U.S. Army Corps of Engineers, Jure 1972), or with some other equivalent watertight standard.

Section 4.03 Special Requirements for Manufactured Homes

- Where cermitted within any identified floodplain area, all manufactured homes and additions thereto shall be:
 - Placed on a permanent foundation,
 - Elevated so that the lowest floor of the manufactured home is one and one half (1-1/2) feet or more above the elevation of the one hundred (100) year flood,
 - Anchored to resist flotation, collapse, or lateral movement.

ARTICLE V ACTIVITIES REQUIRING SPECIAL PERMITS

Section 5.00 General

In accordance with the administrative regulations promulgated by by the Department of Community Affirs to implement the Pennsylvania Flood Plain Management Act, (Act 1978-166), the following obstructions and activities are prohibited if located entirely or partially within an identified floodplain area unless a Special permit is issued:

- A. hospitals (public or private)
- B. nursing homes (public or private)
- C. jails or prisons
- D. new manufactured home parks and manufactured home subdivisions, and substantial improvements to existing manufactured home parks.

ARTICLE V. ACTIVITIES REQUIRING SPECIAL PERMITS SHALL BE AMENDED TO INCLUDE THE FOLLOWING SECTION.

Section 5.01 Application Requirements for Special Permits

Applicants for Special Permits shall provide five (5) copies of the following items:

- A. A written request including a completed Building Permit Application Form.
- B. A small scale map showing the vacinity in which the proposed site is located.
- C. A plan of the entire site, clearly and legibly drawn at a scale of one (1) inch being equal to one hundred (100) feet or less, showing the following:
 - 1. north arrow, scale and date;
 - topography based upon the National Geodetic Vertical Datum
 of 1929, showing existing and proposed contours at
 intervals of two (2) feet;
 - 3. all property and lot lines including dimensions, and the size of the site expressed in acres or square feet;
 - 4. the location of all existing streets, drives, other accessways, and parking areas, with information concerning widths pavement types and construction, and elevations:

- 5. the location of any existing bodies of water or valencourses, buildings, structures and other public or primate facilities. Including vailroad tracks and facilities, and any other natural and man-made features affecting, or affected by, the proposed activity or development;
- 6. The location of the floodplain boundary line, information and spot elevations concerning the one hundred (100) year flood elevations and information concerning the flow of waver including direction and velocities;
- 7. the location of all proposed buildings, structures, utilities, and any other improvements; and
- 8. any other information which the municipality considers necessary for alequate review of the application.
- D. Plans of all proposed buildings, structures and other improvements, clearly and legibly drawn at suitable scale showing the following:
 - sufficiently detailed architectural or engineering drawings including floor plans, sections, and exterior building slevations, as appropriate;
 - 2. for any proposed building, the elevation of the lowest floor (icoluding basement) and, as required, the elevation of any other floor;
 - 3. complete information concerning flood depths, pressures, velocities, impact and uplift forces, and other factors associated with the one hundred (100) year flood;
 - detailed information concerning any proposed floodproofing measures;
 - cross-section drawings for all proposed streets, drives, uther accessways, and parking areas, showing all rightsof-way and pavement widths;
 - 6. profile drawings for all proposed streets, drives, and vehicular accessways including existing and proposed grades; and
 - 7. plans and profiles of all proposed sanitary and storm sewer systems, water supply systems, and any other utilities and facilities.
- E. The following data and documentation:

- 1. Certification from the applicant that the site upon which the activity or development is proposed is an existing separate and single parcel, owned by the applicant or the client he represents;
- 2. certification from a registered professional engineer, architect, or landscape architect that the proposed construction has been adequately designed to protect against damage from the one hundred (100) year flood;
- 3. a statement, certified by a registered professional engineer, architect, landscape architect, or other qualified person which contains a complete and accurate description of the nature and extent of pollution that might possibly occur from the development during the course of a one hundred (100) year flood, including a statement concerning the effects such pollution may have on human life:
- 4. a statement certified by a registered professional engineer, architect, or landscape architect, which contains a complete and accurate describition of the effects the proposed development will have an one hundred (100) year flood abovations and flows;
- 5. a statement, certified by a registered professional engineer, architect, or landscape architect, which contains a complete and approve description of the kinds and amounts of any above badyant materials or debris that may possibly exist or be rocated on the site below the one hundred (100) what flood alevation and the effects such materials and debris may have on one hundred (100) year flood elevations and flows:
- 6. the appropriate component of the Department of Environmental Resources: "Planning Module for Land Development";
- 7. where any excavation or grading is proposed, a plan meeting the requirements of the Department of Environmental Resources to emplement and maintain erosion and sedimentation control;
- 8. any other applicable mermits such as, but not limited to, a permit for any activaty regulated by the Department of Environagedal Resoncess ander Section 302 of Act 1978-166; and
- 9. an evacuation plan which fully explains the manner in which the site will be safely evacuated before or during the course of a machualred (190) year flood.

Section 5.02 Application Review Procedures

Upon receipt of an application for a Special Permit by the Fannett Township, the following procedures shall apply in addition to those of Article II:

- A. Within three (3) working days following receipt of the 'application a complete copy of the application and all accorpanying occumentation shall be forwarded to the County Flanning Cormission by registered or certified mail for its review and recommendations. Copies of the application shall also be forwarded to the Fannett Township Planning Commission and Fernett Township Engineer for review and conment.
- B. If ar application is received that is incomplete, the Township shall notify the applicant in writing, stating in what respects the application is deficient.
- C. If the township decises to disapprove an application, it shall notify the applicant in writing, of the reasons for the disapproval.
- D. If the Founship approves an application, it shall file written notification, together wath the application and all pertinent information, with the hopertheny of Community Affairs, by registered or certified mail, within five (5) working days after the date of approval.
- E. Before assuing the Special Permit, the Township shall allow the Department of Community Affairs thirty (30) days, after receipt of the notification by the Department, to review the application and decision made by the Township.
- F. If the Township does not receive any communication from the Department of Community Affairs during the thirty (30) day review period, it may issue a Special Permit to the applicant.
- G. If the Department of Community Affairs should decide to disapprove an application, it shall notify the Township and the applicant, in writing, of the reasons for the disapproval, and the Township shall not issue the Special Permit.

Section 5.03 Special Technical Requirements

A. In addition to the requirements of Article IV of this Ordinance, the following minimum requirements shall also apply to any proposed development requiring a Special Permit. If there is any conflict between any of the following requirements and those in Article IV Ordinance or in any other code, ordinance, or regulation, the more

restrictive provision shall apply.

- B. No application for a Special Permit shall be approved unless it can be determined that the structure or activity will be located, constructed and maintained in a manner which will:
 - 1. Fully protect the health and safety of the general public and any occupants of the structure. At a minimum, all new structures shall be designed, located, and constructed so that:
 - a. the structure will survive inundation by waters of the one-hundred (100) year flood without any lateral movement or damage to either the structure itself, or to any of its equipment or contents below the one-hundred (100) year flood elevation.
 - b. the lowest floor elevation will be at least one and one-half (1-1/2) feet above the one-hundred (100) year flood elevation.
 - c. the occupants of the structure can remain inside for an indefinite period of time and be safely evacuated at any time during the one-handred (100) year flood.
 - 2. Prevent any significant possibility of pollution, increased flood levels of flows, or debris endangering life and property.

All hydrologic and hydraulic analyses shall be undertaken only by professional engineers or others of demonstrated qualifications, who shall certify that the technical methods used correctly reflect currently accepted technical concepts. Studies, analyses, computations, etc. shall be subritted in sufficient detail to allow a thorough technical review by the Township and the Department of Community Afrance.

ARTICLE VI EXISTING STRUCTURES EM IDENTIFIED FLOODPLAIN AREAS

Section 6.00 General

Structures existing in any identified floodplain area prior to the enactment of this Ordinance may continue to remain, provided that:

A. Any modification, olderation, rescription, or improvement of any kind to an existing structure, to an extent or amount of flifty (50) percent or more of its market value, shall constitute a substantial improvement and shall be undertaken only in full compliance with the provisions of this Ordinance.

ARTICLE VII VARIANCES

Section 7.00 General

If compliance with any of the requirements of this Ordinance would result in an ecceptional landship to a prospective builder, developer or landowner, the Township may, upon request, grant relief from the strict application of the requirements.

Section 7.01 Variance Procedures and Conditions

Requests for variances shall be considered by the Township in accordance with the procedures contained in Section 2.08 and the following:

- 1. Except for a possible modification of the freeboard requirements involved, no variance shall be granted for any of the other requirements pertaining specifically to development regulated by Special Permit (Art.V) or to Development Which May Endanger Human hafe (Sec. 4.02).
- 2. If granted, a variance shall involve only the least modification necessary to provide relief.
- 3. In granting any variance, the Township shall attach whatever reasonable conditions and safeguards it considers necessary in order to protect the public health, safety, and welfare, and to achieve the objectives of this Ordinance.
- 4. Whenever a variance is granted, the Township shall notify the applicant in writing that:
 - a. the granting of the variance may result in increased premium rates for flood insurance.
 - b. such variances may ancrease the risks to life and property.
- 5. In reviewing any request for a variance, the Township shall consider, at a minimum, the following:
 - a. that there is good and sufficient cause.
 - b. that failure to grant the variance would result in exceptional hardship to the applicant.
 - c. that the granting of the variance will (i) neither result in an unacceptable or prohibited increase

in flood heights, additional threats to public safety, or extra-ordinary public expense, (ii) nor create nuisances, cause fraud on, or victimize the public, or conflict with any other applicable State or local ordinances and regulations.

6. A complete record of all variance requests and related actions shall be maintained by the Township. In addition, a report of all variances granted during the year shall be included in the annual report to the Federal Insurance Administration.

Notwithstanding any of the above, however, all vacuatures shall be designed and constructed so as to have the capability of resisting the one-hundred (100) year flood.

ARTICLE VIII DEFINITIONS

Section 8.00 General

Unless specifically defined below, words and phrases used in Ordinance shall be interpreted so as to give this Ordinance its most reasonable application.

Section 8.01 Specific Definitions

- A. Accessory use or structure a use or structure on the same lot with, and on a nature customarily incidental and subordinate to, the principal use or structure.
- B. Building a combination of materials to form a permanent structure having walls and a roof. Included shall be all mobile homes and trailers to be used for human habitation.
- C. Construction the construction, reconsumetion, renovation, repair, extension, expansion, alteration, or relocation of a building or structure, including the placement of mobale homes.
- D. Development any man-made change to improved or unimproved real estate, including but not limited to buildings or other surreduces, the placement of mobile home, streets, and other paving, utilities, filling, grading, excavation, mining, dredging, or drilling operations and the subdivision of land.
- E. Flood a temporarry numbersion of mornally dry hand area.
- F. Floodplain area a relatively flat or low land area which is subject to partial or complete Frundation from

- an adjoining or nearby stream, river or watercourse; and/or any area subject to the unusual and rapid. accumulation of surface waters from any source.
- G. Flood-proofing means any combination of structural and ron-structural additions, changes, or adjustments to structures which reduce or climinate flood damage to real estate or improved real property, water and sanitary facilities, structures and their contents.
- H. Minor repair the replacement of existing work with acceivalent materials for the purpose of its routine indicted and upkeep, but not including the cutting away of any wall, partition or portion thereof, the removal or cutting of any structural beam or bearing support, or the removal or change of any required means of agrees, or rearrangements of parts of a structure effecting the exitway requirements; nor shall minor repairs include addition to, alteration of, replacement or relocation of any standpipe, water supply, sewer, drainage, drain leader, gas, soil, waste, vent or similar piping, electric wiring or mechanical or other work affecting public health or general salety.
- I. Manufactured home a structure, transportable in one or more sections, which is built on a permanent chassis and is designed for use with or without a permanent foundation wher connected to the required utilities. The term includes park trailers, travel trailers, recreational, and other similar vehicles placed on a site for more than 180 consecutive days.
- J. Manufactured home park a parcel (or contiguous parcels) of land which has been planned and improved for the placement of two or more manufactured homes.
- K. Obstruction any wall, dam, wharf, embankment, levee, dike, pile abutment, projection, excavation, channel, rectification, culvert, building, fence, stockpile, refuse fall, structure, or matter in, along, across or projectinng into any channel, watercourse, or flood-prone area, which may impede, retard, or change the direction of the flow of water either in itself or by catching or collecting debris carried by such water or is placed where the flow of the water might carry the same downstream to the damage of life and property.
- L. One hundred (100) year flood a flood that, on the average, is likely to occur once every one-hundred (100) years (i.e. that has one (1) percent chance of

occurring each year, although the flood may occur in any year).

- Regulatory flood elevation the one-hundred (100) year flood elevation plus a freeboard safety factor of one and one-half (1-1/2) feet.
- Special permit a special approval which is required for hospitals, nursing homes, jails, and new manufactured home parks and substantial improvements to such existing parks, when such development is located in all, or a designated portion of a floodplain.
- Structure anything constructed or erected on the ground or attached to the ground including, but not limited to buildings, sheds, manufactured homes, and other similar items.
- P_{\star} Subdivision the division or redivision of a low. tract, or parcel of land by any means late two or more lots, tracts, parcels or other livisions of lands including changes in existing lot lines for the purpose, whether immediate or future, or lease, transfer or ownership or building or lot development. The division of land for agricultrual purposes into parcels of more than ten (10) acres, not involving any new street or essement of access, shall be exempted.

ARTICLE IX REPEALER

Ordinance No. 86 - is repeated by the enactaest hereof.
