ORDINANCE NO. 55-5

AN ORDINACE, LAYING OUT AND OPENING A ROAD IN FANNETT TOWNSHIP, FRANKLIN COUNTY, PENNSYLVANIA

BE IT ORDAINED AND ENACTED That the Supervisors of Fannett Township, Franklin County, Pennsylvania, and it is hereby ordained and enacted by authority of the same.

SECTION I

That the road known as Indian Spring Trail, in Amberson Valley Estates, subdivision, Fannett Township, Franklin County, Pennsylvania is hereby laid out and opened on a course the centerline of which begins at a proposed 100' foot culdesac at Lot No. 1 Phase 1; thence along centerline of said road North 74 degrees 55 minutes East 608.18 feet; thence by a curve to the left South 77 degrees 47 minutes East having a chord length of 222.29 feet, North 87 degrees 36 minutes East 457.70 feet; thence North 9 degrees 31 minutes East 89.81 feet; thence North 39 degrees 14 minutes East 74.60 feet, North 13 degrees 49 minutes West 126.24 feet; thence North 34 degrees 22 minutes West 226.94 feet; thence North 29 degrees 37 minutes West 159.47 feet; thence North 42 degrees 22 minutes West 126.02 feet; thence North 34 degrees 23 minutes West 484.52 feet; thence North 17 degrees 39 minutes West 125.97 feet; thence North 52 degrees 59 minutes East 142.65 feet; thence North 63 degrees East 131.20 feet intending to be all of Indian Spring Trail in Amberson Valley Estates and being in width 33 feet.

SECTION II

That the road known as Second Narrows Road in Amberson Valley Estates, Fannett Township, Franklin County, Pennsylvania is hereby laid out and open on a course from the centerline at the intersection with Indian Spring Trail North 89 degrees 30 minutes East 695.9 feet and intended to be all of that road known as Second Narrows Road in Amberson Valley Estates.

SECTION III

That the road known as Timber Lane in Amberson Valley Estates, Fannett Township, Franklin County Pennsylvania is hereby laid out and opened on a course from the intersection of Timber Lane with Indian Spring Trail South 64 degrees 37 minutes West 402.10 feet; thence South 64 degrees 37 minutes East 201.85 feet; thence South 65 degrees 35 minutes West 210.6 feet; thence South 65 degrees 35 minutes West 151.98 feet, North 78 degrees 50 minutes West 141.94 feet; thence North 73 degrees 15 minutes West 509 feet and intended to be all of Timber Lane in Amberson Valley Estates and being in width 33 feet.

That the road known as Sherman Trail in Amberson Valley Estates, Fannett Township, Franklin County, Pennsylvania is hereby laid out and opened on a course from the intersection of Maple Lane and Sherman Trail South 44 degrees 15 minutes West 330.53 feet; thence South 48 degrees 56 minutes East 346.30 feet; thence South 25 degrees 33 minutes West 106.22 feet; thence South 43 degrees 20 minutes West 351.4 feet; thence South 43 degrees 20 minutes West 231.1 feet; thence South 45 degrees 50 minutes West 201.7 feet to an intersection at Second Narrows Road and being in width 33 feet.

SECTION V

That the road known as Maple Lane in Amberson Valley Estates, Fannett Township, Franklin County, Pennsylvania is hereby laid out and opened on a course starting at a culdesac at Lot #22 of the said Amberson Valley Estates South 7 degrees 56 minutes East 236.93 feet; thence South 44 degrees 53 minutes East 162.52 feet; thence South 16 degrees West 203.22 feet; thence South 86 degrees 15 minutes East 92.25 feet; thence North 87 degrees 24 minutes East 148.80 feet; thence South 6 degrees 20 minutes West 74.98 feet being part of Maple Lane and being in width 33 feet.

SECTION VI

There is adopted as a part of this Ordinance the plan of the foregoing road shown the location thereof.

SECTION VII

Said road shall hereafter be and become a part of the public road system of Fannett Township.
